Discussion of Comprehensive Plan/Rezoning/Redistricting services

Mayor Graves went over the prices and details for doing a comprehensive plan, rezoning and redistricting. CMPDD stated that they will do a Comprehensive Plan for \$68,000 and the rezoning for \$19,500.00. Their work will include GIS links on our website. Mr. Slaughter will

doing a Comprehensive Plan for \$35,000 to \$45,000, the rezoning for \$8,000 to \$10,000. His plan doesn't include anything with GIS links. Mr. Slaughter can do the redistricting for \$8,000 to \$12,000.00. CMPDD referred us to GTPDD for redistricting. GTPDD can do redistricting for around \$7,500 plus up to \$1,200 for travel.

Katie Harbin stated that she spoke to Mr. Slaughter regarding getting a better break down with an exact price however Mr. Slaughter advised that the breakdown in the agreements previously given would be what we need to go by. Mr. Slaughter stated that he would put PDF copies of our information on the website, not GIS links. Mrs. Harbin also advised the Mayor and Board of Aldermen that CMPDD referred us to GTPDD for redistricting and they stated their price would be \$7,500 plus up to \$1,200 for travel.

Mayor Graves stated that if we don't do this for another 10 years, we will be way behind.

Alderman Moore stated it will be better to have GIS. It might cost more on the front end, but it is worth end.

Alderman Simpson stated when we talk to Slaughter, he's going to do the same thing as he's done before, not doing GIS.

Alderman Hale stated we are behind now. I'd hate to see how behind we'd be in 10 years if we didn't do anything now

Alderman Tanksley asked do y'all think CMPDD for the comprehensive plan and rezoning and Slaughter for redistricting.

Mayor Graves stated we can do the redistricting later if you want.

Alderman Hale stated I think it would be a benefit to have a different company to do this one than from the last one.

Alderman Moore stated and a benefit that CMPDD is doing the work for Tate County right now.

Alderman Dear asked if the GIS system is changing now?

Jim Huestis stated that Tate County has TSC now, it's a base or form of GIS.

Alderman Hale stated we are way behind now, we need to catch up.

Alderman Simpson asked if Mr. Slaughter was doing the GIS.

Mayor Graves stated not from his conversation with Katie.
