BE IT REMEMBERED that the Mayor and Board of Aldermen met on March 22, 2022, at 5:00 P.M., this being the regular recessed meeting time. Mayor Greg Graves called the meeting to order and the following Aldermen were present: Dear, Hale, Moore, Simpson and Tanksley. Also present were: Katie Harbin, City Clerk; Ginger Miller, City Attorney; Matt Defore, Assistant Police Chief; Ethan Foresman, Fire Chief; Chantay Rhone, FLSE/PIO; Brevin Holden, Fire Inspector; Jim Huestis, Building Official; Jeff Rich, Public Works Director; Francis Johnson, Deputy City Clerk, Elizabeth Clark with Butler Snow, Michael Cathey, Suzan Erber, Bud Donahou, Matthew Raff, Greg Smith with Mendrop Engineering, Lindsey Harvill with JATP, Caroline Lanier with JATP, Brett Brown, and Britt Herrin with EDF.

Alderman Hale gave the invocation.

## Request from Tree City Board for funding (Bud Donahou and Suzan Erber)

Bud Donahou presented the request on behalf of the Tree City Board and handed out information to the Mayor and Board of Aldermen. Mr. Donahou went over what the Tree City Board does, how they have gotten the City to be recognized as a Tree City over the years and also as a Sycamore Arboretum. Mr. Donahou explained that the last time they applied and received the distinction of being a Tree City and a Sycamore Arboretum, they used about \$40,000 worth of grants. The Tree City Board is out of funds and have unfortunately let the duties of keeping our certifications current fall behind. Mr. Donahou stated that the Tree City Board would like to request about \$3,000 now and also would like to be considered during budget time each year to receive \$1,000 each year for funding. We have to recertify as a Tree City and for the Arboretum.

Suzan Erber spoke about the need and benefits of these two certifications. Mrs. Erber spoke about the Sycamore Arboretum of Senatobia, MS book that they had published and need to update. We put this book out in several places including rest areas around the state and some of the students at Northwest Community College use this book for class assignments. People from all over come to look at the trees in our community.

Mayor Graves asked what are some of the benefits the City would see from this?

Bud Donahou answered education is the biggest benefit. Trees, there are about 14 benefits from the trees themselves. It will bring people into the community, tourism will benefit.

Mayor Graves asked if they will have an active Board now.

Bud Donahou answered yes, Suzan Erber, Matthew Raff and myself.

Matthew Raff stated that the signs they are looking to get will not fade as bad as the ones we have now.

Mayor Graves asked if there will be any state or national recognition? Are there any grants?

Bud Donahou answered it will bring in people from all over to look at the trees and to use the book to find them all. We will look for grants, but don't have any as of right now. We have to recertify for the Tree City every year and every three years for the Arboretum.

Suzan Erber stated that Tree City and Arboretum are separate things. The Tree City is the big one and we us the Arboretum for the qualifications when applying for Tree City.

Motion was made by Alderman Hale, seconded by Alderman Moore, to approve the request from the Tree City Board for funding in the amount of \$2937.92, to update the Sycamore Arboretum information and the Tree City certification, both which will benefit the City of Senatobia by means of advertising and bringing into favorable notice the opportunities, possibilities and resources of the City. All voting yea, motion carried.

## Mendrop Engineering, Road Paving Discussion

Greg Smith with Mendrop Engineering presented information to the Mayor and Board of Aldermen regarding a Road Maintenance Program done by Civil Link. This program is a great option to have your roads evaluated and a plan put in place to be able to make the best repairs and save the most money over a period of time.

Steve Bigelow with Civil Link gave a presentation about the Road Maintenance Program. Mr. Bigelow spoke on the steps of the program, how it works, and the different materials used. Mr. Bigelow that the roads will be ranked in order of condition. Some roads may not need anything done, some may just need a micro seal, slurry seal, or crack seal, and some may need to be dug up and totally redone. Without having any information on the roads, but going by your size of a city, I would guess that you will end up needing to budget \$800,000 to \$1,000,000 a year for road maintenance.

Mayor Graves asked if one needs one thing and another needs something different, do you do that or will it cost more?

Steve Bigelow answered yes, we will go in and rank the roads, do a cost analysis, and put together a 7-to-10-year plan for you. The cost for this plan is about \$38,000. It's a lot of money, but it will save you money in the long run. If road's crack, you need to seal them up, so the water doesn't get in there. Once water starts getting into the cracks and down to the foundation, you will have more costly repairs.

Alderman Simpson stated the traffic count plays into it also, correct, on a major road versus a subdivision road, we'd take care of the more trafficked roads first.

Steve Bigelow answered yes.

Alderman Dear stated we have a lot caving in.

Steve Bigelow stated I've had machines fall in the road, from caving. If it gets too bad, you start over.

Alderman Dear stated we had some done four years ago, and they are now caving in.

Steve Bigelow stated if you don't have a good foundation, it can do that.

Alderman Moore stated on what you're going to prepare, say we have a 10x10 spot on a mile long road, will you just show repairing the spot on your report?

Steve Bigelow answered yes. Just show that to fix only that area.

Alderman Hale stated we can use the infrastructure modernization tax money.

Steve Bigelow stated it takes about 4 months for us to evaluate your roads and have a plan back to you.

Motion was made by Alderman Hale, seconded by Alderman Simpson, to authorize to engage Mendrop Engineering to have a Road Maintenance Plan prepared for the City, at a cost of \$37,202.00. All voting yea, motion carried.

We can decide to do an amount lower, but not more that the \$4,000,000.00. Mrs. Clark stated that the no protest date is set for May 3<sup>rd</sup>. If there are no protest, from that date you have 2 years to issue the bond.

Alderman Moore asked if it was 2 years to spend.

Elizabeth Clark answered you have 3 years to spend after closing.

Jeff Rich, Public Works Director, passed out some pictures of the ditch to the Mayor and Board of Aldermen along with a quote he received to repair it from the culvert to where the rip rap stops now

Mayor Graves stated we can look at the regulations for the ARPA money, to see if we can use that for this issue.

This will show us if we are doing good, or if there is somewhere we need improvement. We analyzed several topics. For tonight we will look at the arrests and traffic citations. It used demographics and population for tools. It is broken down into proactive and reactive calls. After you get your results, you then take them and do it several different ways to make sure your results are accurate. After reviewing all of our information, it showed us that we are where we need to be. We share this information with our officers to encourage good trends and/or correct where needed.

Alderman Hale stated I'm glad you're looking at it. A lot of places are afraid to even look at it.

The Mayor and Board of Aldermen thanked Assistant Police Chief for presenting this information and advised him that they would like to see updates like this more often.
