Also present were Ginger Miller, City Attorney; Karen VanSickle, City Clerk; Jim Huestis, Building Inspector; Richard Chandler, Police Chief; Matt Defore, Assistant Police Chief, and Ethan Foresman, Fire Chief.

Motion was made by Tanksley, seconded by Moore, to advertise for the construction of the WWTP. All present voting yea, motion carried.

Motion was made by Moore, seconded by Hale, to not allow the rezoning of Roderick Webb's rezoning request, from R2 to R4, at 208 Marvin Street. The aldermen voted as follows:

Motion was made by Moore, seconded by Simpson, to come out of executive session. All voting yea, motion carried.

Motion was made by Dear, seconded by Simpson, to terminate Travis Holloway, effective immediately. All voting yea, motion carried.

Motion was made by Simpson, seconded by Dear, to adjourn until November 3, 2020. All voting yea, motion carried.
