BE IT REMEMBERED that the Mayor and Board of Aldermen met on October 5, 2021, at 5:00 P.M., this being the regular recessed meeting time. Mayor Graves called the meeting to order and the following Aldermen were present: Dear, Hale, Moore, Simpson and Tanksley. Also present were: Katie Harbin, City Clerk; Ginger Miller, City Attorney; Ethan Foresman, Fire Chief; Richard Chandler, Police Chief; Matt Defore, Assistant Police Chief; Jeff Rich, Public Works Director; Brevin Holden, Code Compliance Officer/Fire Inspector; Courtney Scott, Animal Shelter Director; Earnestine Cowan, Utility Supervisor; Jim Huestis, Building Official; Michelle Huestis, Donna Vecellio, and Jamie Sowell.

Alderman Tanksley gave the invocation.

Discussion of School Board Member Appointment

Mayor Graves advised the Board that he met with each of the gentlemen this past week. All seem very good and like a good fit for the position. I wanted each of you to be able to hear from them and ask any questions you might have.

Raney Young spoke to the Board of Aldermen as to why he would be a good fit for the open School Board position. Mr. Young stated that he is a Pastor, he retired from the Army after 26 years of serving, has 5 kids with the youngest being in the school system.

Keegan Armstrong spoke to the Board of Aldermen as to why he would be a good fit for the open School Board position. Mr. Armstrong is from Sardis but moved here 11 years ago. Mr. Armstrong has 3 kids, all in the school system. Mr. Armstrong has graduated from the University of Mississippi and works in education.

Jason Cooper spoke to the Board of Aldermen as to why he would be a good fit for the open School Board position. Mr. Cooper has lived in Tate County for 12 years and has had a business in Senatobia for 12 years for Physical Therapy. Mr. Cooper has two children in the school system.

Motion was made by Alderman Simpson, seconded by Alderman Tanksley, to table this item for further review. All voting yea, motion carried

Issues with water rate increase

Mayor Graves advised the Board that we inadvertently had the new water rates on the bills that went out, due this month.

Utility Supervisor Earnestine Cowan went over what happened with the bills. Mrs. Cowan stated there was a miscommunication as to when the new rates needed to be entered and the bills were mistakenly sent out with the new rates. We have since adjusted the bills that were incorrect and removed the new rates. We also had some issues with the readings.

Alderman Simpson asked if someone's bill happened to be estimated low and then read the next cycle, they could get a higher bill, correct?

Earnestine Cowan answered yes.

Mayor Graves stated that we will start the new fees with the readings that start after October 15th, since the effective date is October 15th.

Authorize to accept the lowest and best bid for construction / renovation of the new Police Department Building

Presentation of renewal rates for ancillary lines of insurance coverage

Donna Vecellio, Insurance Consulting Group, went over the renewal rates for the ancillary insurances. Mrs. Vecellio advised that by moving them all with Principal, it will be a cost savings and easier for administration staff.

Motion was made by Alderman Hale, seconded by Alderman Moore, to move the ancillary lines of insurance coverage to Principal, keeping the same benefit levels that we currently have. All voting yea, motion carried

Pressure washing Downtown and Boy Scout Building – Jamie Sowell

Jamie Sowell spoke to the Mayor and Board of Aldermen regarding a pressure washing downtown project she is doing. Mrs. Sowell has gotten a quote to pressure wash the downtown area including sidewalks, curbs, City buildings, etc. She has also gotten businesses a discounted price for them to do their building, awning, etc, at the same time we are doing ours. Main Street has put money aside with a grant to get this done. Mrs. Sowell is asking the City to pay for the City portion, which comes to \$6,000.00.

Motion was made by Alderman Moore, seconded by Alderman Dear, to approve to use \$6,000 from the Downtown Revitalization grant money to pressure was the City sidewalks, curbs, and City buildings. All voting yea, motion carried.

Jamie Sowell spoke to the Mayor and Board of Aldermen regarding the City owned old Boy Scout building. Mrs. Sowell stated that this building is just sitting there, falling in. There are utility lines under it, but it is a great building and we need to save it. We are working now to clean it up to use it for the Christmas Village on November 6th. I am asking for some help. Main Street will pay to help fix the building up, but we want to know the City will help pay also, before we invest a lot into it. We don't want to do a lot to it and then the City decide to tear it down. The building is structurally sound, but does need work and a new roof. I've spoken to Kevin and Trey and they advised that the City could use the Downtown Revitalization grant money to improve the building, if you want to.

Building Official Jim Huestis stated that construction wise it is sound. It does have a leaking roof. We did get an estimate to replace the roof last year, it was around \$15,000 to \$20,000.

Mayor Graves stated I think we'd need an estimate before voting on just spending money to fix the building.

Jamie Sowell stated I think \$50,000 would be a good start. Mrs. Sowell stated we could possibly use the Small Town Center to do a rendering of the building, to show what could be done. Main Street has a credit with them and I can see about using our credit for this building.

Alderman Moore stated I think it is a great idea, but Small Town Center might come back and say you need to spend a lot more on it to make it usable. Why would we spend the money before getting a rendering.

Jamie Sowell stated I'm going to listen to the professionals. I just don't want to put more time and money into the building if the City doesn't want to save it.

Alderman Simpson stated I think if we can use the building for all of the different events, I'd rather save the building than sell it.

Mr. Rich informed the Mayor and Board that he met with the Cor of Engineers regarding the ditch carrying the water out of the City. They put it on their list. Also, I have a meeting with the Grenada Railway regarding the tracks at Shands Bottom Rd.
